

## **SHORT EXAM ON ILLUSORY CONTRACTS: Ten Things That Would Cause God's Covenant To Be Invalid.**

This is a short exam to test your logical reasoning ability. If you can write a paragraph for each hypothetical example explaining why it is an "illusory" and thus "invalid" covenant, then you are ready to learn and validly agree to God's only and actual true contractual Covenant of all His laws in scripture.

1. If God had said, "These are the laws of my covenant, but I reserve a right to change any law in the future," it would have been "illusory" and "invalid," not an actual contractual Covenant.
2. If God had said, "These are the laws of my covenant, but if you have faith in me, then you need not obey all my laws to be called my people," it would have been "illusory" and "invalid," not an actual contractual Covenant.
3. If God had said, "These are the laws of my covenant, but I appoint Moses as leader with the power to alter or change my laws," it would have been "illusory" and "invalid," not an actual contractual Covenant.
4. If God had said, "These are the laws of my covenant, but I appoint Moses with the power to 'loose or bind' individuals to those laws by dispensations that loosen that individual from having to obey all my laws," it would have been "illusory" and "invalid," not an actual contractual Covenant.
5. If God had said, "These are the laws of my covenant, but if you disobey any law, then Jesus will 'in proxy substitute atonement for you' instead of you having to atone for your own sins against my laws," then it would have been "illusory" and "invalid," not an actual contractual Covenant.
6. If God has said, "These are the laws of my covenant, but if you disobey any of these laws, then Jesus will purchase you back into the covenant," it would have been "illusory" and "invalid," not an actual contractual Covenant.
7. If God had said, "These are the laws of my covenant, but you do not have to actually agree to obey all my laws so long as you have faith in Jesus," it would have been "illusory" and "invalid," not an actual contractual Covenant.
8. If God had said, "These are the laws of my covenant, but you can offer litanies, prayers, fasts, and rosaries, instead of actually having to obey all my laws," it would have been "illusory" and "invalid," not an actual contractual Covenant.
9. If God had said, "These are the laws of my covenant, but if you disobey any of my laws, then you can be 'absolved' and immediately restored to the covenant without having to actually work hard to prove yourself repentant and contractual capacity again," it would have been "illusory" and "invalid," not an actual contractual Covenant.
10. If God had said, "These are the laws of my covenant, but you do not have to agree to obey all my laws because I love everyone equally," it would have been "illusory" and "invalid," not an actual contractual Covenant.

### **EXAMPLES OF INVALID "ACCEPTANCES" OF GOD'S CONTRACTUAL COVENANT:**

11. If a man says, "I agree to all your laws God, but I reserve a right to obtain a 'dispensation' from 'the church cleric' to disobey one of those laws," then it is an "invalid acceptance," and not a valid contractual Covenant.

12. If a man says, "I agree to most of your laws God, but one of those laws I disagree with," it is an "invalid acceptance," and not a valid contractual Covenant.

13. If a woman says, "I agree with all your laws God, but I reserve a right to disobey any law that I do not like from time to time and then get an 'absolution' from 'the church cleric,'" then it is an "invalid acceptance," not a valid contractual Covenant.

14. If a man says, "I agree to some of your laws God, but I think 'faith' in You is more important than obeying all your laws," then it is an "invalid acceptance," not a valid contractual Covenant.

The first step to being able to validly contractually agree to God's only Covenant is to be honest with Him about what is required for His contractual Covenant to be "valid" and "not illusory." Therefore I ask each of the readers to write an additional paragraph explaining how God's contractual Covenant requires both God and each person who hopes to become a valid member of His Covenant to be fully bound in law to obey all His laws, at all hours for the duration of His and our lives, without exceptions and thus without any "alterations," "dispensations," nor "absolutions." The point is that God's laws must be constant, firm, and not able to be altered in order for God to have a valid contractual Covenant of all His laws. Any suggestion that God 'has changed His laws,' or that 'He somehow allows a pope to change His laws' or to 'dispensation individuals from having to obey a law,' is an illogical suggestion, and it would make God's offered covenant "illusory" and "invalid." If God had allowed any method of changing even a single law, or to 'dispensation' any individuals from having to fully obey a law, the entire covenant would have become "illusory" and therefore "invalid." God's laws have to be permanent, timeless, and not able to be changed by any generation in order for God to have a valid contractual Covenant. His laws in scripture which He spoke directly to Moses are permanent laws. You must agree to all those laws in order to validly contract God's Covenant. "Disagreement" is never a valid "agreement." "Ignorance" is never a valid "agreement." "Misunderstanding" about any of His laws is never a valid "agreement." Only fully informed consent to obey all His laws in scripture is a valid contractual Covenant "agreement."

### **TRUE or FALSE Questions:**

15. God must have authored laws that must remain the same laws for all generations in order to have authored a valid contractual Covenant, thus "not illusory"? Answer: True.

16. God has the power to issue 'dispensations' from having to obey one or more of His laws without thereby invalidation His covenant as "illusory"? Answer: False.

17. God can allow Moses or a priest to issue such 'dispensations' without thereby nullifying His covenant as "illusory"? Answer: False.

18. God can 'absolve' ('absolution') an individual's violations of His laws without thereby nullifying His contractual covenant of consequences as "illusory"? Answer: False.

19. God's contractual Covenant requires even God to obey its promise of "if you obey My laws, then I will love and bless you, but if you disobey My laws, then I will punish you," of He nullifies the entire covenant if He ignores or violates those promised terms and conditions? Answer: True.

20. God's contractual Covenant requires obedience to all His laws in order to be a valid Covenant and "not illusory," thus an individual who claims to 'have faith in God' but who violates any law of God is thereby not a valid member of God's Covenant people? Answer: True.

21. To be a valid contractual Covenant, God must require all persons to personally obey all His laws, and it therefore does not allow any 'in proxy' substitute performance by an alleged 'redeemer'? Answer: True.

22. In summary, to have authored a valid and thus "not illusory" contractual Covenant, God must have written a legal agreement of fixed laws that He and all people must obey to validly be parties of that Covenant agreement? Answer: True.

23. Therefore, even God must be fully bound by His agreement, His contractual Covenant of all His laws, or it would be "illusory" and thus "invalid"? Answer: True.

24: God can allow someone else to 'take your place of a cross' without thereby invalidating His contractual Covenant as "illusory"? Answer: False.

Are you ready to agree that God has only one contractual Covenant that He gave through Moses and that can never be changed? Are you ready to agree to all His laws in scripture? Are you ready to agree that neither God nor man can alter any of His laws, nor therefore give any 'dispensations' from those laws? Are you ready to learn and agree to learn and obey God's true Single Person Divine Nature, His true doctrines, and all His laws in scripture? God requires obedience of Him and all His laws, not merely 'faith' in Him. Not is there any such thing a true 'faith' that in any way disobeys one or more of His laws. You must be promising to personally be accountable to obey all His laws and personally accountable for any violations of those laws, or you cannot validly contractually agree to His only Covenant and you will not therefore be one of His Covenant people. The above questions were only a beginning. They test your honesty. It is up to you to read the scripture laws given to Moses as the contractual Covenant and to personally agree to obey those laws in agreement with God. That Covenant is His only offered plan for your love and protection from Him. He has no other plan.
